HOW WE SUPPORT INTERNATIONAL INVESTORS

Market Pulse is designed to reduce friction at the beginning of an investment process. We help international counterparties understand who is involved, what information is available, what further documentation is required and which local parties need to be coordinated.

- Project sourcing and initial opportunity screening.
- Coordination with project owners and local counterparties.
- Preparation and organisation of investor-facing information.
- Initial investor outreach and introductory communications.
- Meeting, presentation and negotiation coordination.
- Collection and controlled exchange of project documentation.
- Coordination of legal, financial, technical, tax and commercial due-diligence workflows.
- Communication with banks, financial institutions, international organisations and external advisers.

Current focus areas include: energy, infrastructure and selected strategic investment projects in the Kyrgyz Republic and Central Asia.
